Old Beechwold Association Meeting October 25, 2021 – Virtual Meeting via Zoom

#### MINUTES

President Jennifer Alexander called meeting to order at 7 pm. Thirty-one residents, including officers, were represented. Jennifer called for minutes of January 28, 2020 meeting approved. They were approved.

#### **REPORTS OF OFFICERS AND COMMITTEES**

### Treasurer's report (Becca Donnally)

The association has an ending balance of \$22,146.52 as of 9/30/2020 (report below). Another notice will be sent to those who've not paid association dues for this year.

Leaf collection, for those who have paid association dues, is scheduled to begin Monday, November 22, 2021. Be sure to blow your leaves to the edge of the road and NOT on top of any of the steel plates as they cannot be picked up from there.

## Historic District Actions report (Gail Mahaffey)

Five applications were submitted to the Historic Preservation Commission since the last report in July. All were approved (report below). Please keep in mind, prior approval and a certificate of appropriateness is required from the Historic Preservation Commission for all exterior renovations, including landscaping and tree removal. #### Election Committee report (Jennifer Alexander on behalf of Jack Jackson)

Voting for 2022 OBA Executive Committee officers will take place before the end of this calendar year. Voting will take place via email and Google forms. The floor was opened for nominations for the position; none were offered.

## Arbor Committee report (Lindalee Brownstein)

The Arbor Committee coordinated two workdays in 2021 to help remove invasive species in our common areas and do general clean up. Thank you to the neighbors who participated. Work on a five-to-ten-year plan for our woodlands is still in progress. And Gregg Peace along with other neighbors have been distributing and planting more trees in our neighborhood.

## Social Committee report (Kirsten Minnie)

Please join us for another OBA neighborhood event, this time it's Art on the Triangle at 71 West Jeffrey Place with a companion Art Studio Open House at 162 W Jeffrey Place in the rear above the garage. This

#### **Guest Speakers**

Several representatives (see below for names and contact info) who are, or will be, working on our OBA infrastructure project talked about gas, storm, water and road work plans and answered questions from neighbors.

Luka Papalko from Columbia Gas provided an update on the replacement of gas lines. He mentioned that the work they are doing is lowering gas lines to an appropriate depth to ensure that they don't interfere with any of the city's planned infrastructure updates. In addition, the service lines running from the main line to each home are being replaced. They are also moving any interior gas meters to the outside of the home. Luka shared a map and update on the progress that you can view in the meeting recording. If you haven't been contacted by Columbus Gas, they likely haven't gotten to your area yet. He asked that drivers do their best not to drive through newly restored yards to the sides of the roads. This project will continue into next year. Most of that work will be restoration and "abandonment" to retire the old system once the new system is complete.

Jeremy Cawley, Lead Project Manager for the city on the infrastructure work (replaced Mike Griffiths) mentioned that this work started a few years ago based on water drainage issues and a study that was done. In the meantime, the Blueprint project was initiated. When the work is complete, we will essentially have all new gas lines, water mains, and new storm sewers. All sanitary mains have already been rehabbed or lined.

Jeremy shared that you will likely not see Elite Excavating starting work until after the first of the year. They will start on the North side of the neighborhood. This year, they plan to walk the neighborhood with the City Forester to review the plans for any trees that may be impacted.
